FORM OF COMPULSORY PURCHASE ORDER UNDER SECTION 76 OF AND THE THIRD SCHEDULE TO THE HOUSING ACT, 1966 , AS EXTENDED BY SECTION 10 OF THE LOCAL GOVERNMENT (NO. 2) ACT, 1960 (SUBSTITUTED BY SECTION 86 OF THE HOUSING ACT, 1966) AND AMENDED AND EXTENDED BY THE PLANNING AND DEVELOPMENT ACTS, 2000 - 2009

THE LOCAL GOVERNMENT (No. 2) ACT, 1960, THE ROAD ACTS, 1993 - 2007

LOCAL GOVERNMENT ACTS 1925 - 2003 INCLUDING SECTIONS 11 AND 184 OF THE LOCAL GOVERNMENT ACT, 2001 AND

**Westmeath County Council Compulsory Purchase (No.4)  
Order, 2010  
N52 Carrick Bridge to Clonfad Road Improvement Scheme**

WHEREAS in pursuance of section 10 of the Local Government (No. 2) Act, 1960, as substituted by section 86 of the Housing Act, 1966 as amended by section 6 and the Second Schedule to the Roads Act, 1993 and amended and extended by the Planning and Development Acts, 2000 - 2009, Westmeath County Council (hereinafter referred to as “the Local Authority”) have decided to effect the acquisition of the land to which this order relates under the Housing Act, 1966 (as amended).

NOW THEREFORE it is hereby ordered that:

1) Subject to the provisions of this order, the Local Authority is hereby authorised:

(A) to acquire compulsorily lands for the purposes of construction of the N52 Carrick Bridge to Clonfad Road Improvement Scheme described in Part I of the Schedule hereto shown on drawings sealed with the seal of the Local Authority and deposited at the offices of the Local Authority.

(B) to extinguish the public and, without prejudice to the Local Authority’s rights under Section 83(2) of the Housing Act, 1966, all known private rights of way, easements and other rights described in Part III and Part IV of the Schedule by order made after the acquisition of the land, where the said rights are over the land so acquired or any part thereof, or over land adjacent to or associated with the land so acquired or any part thereof.

(C) to temporarily acquire lands in Part II of the Schedule.

The lands, rights of way, easements and other rights are described in Part I, Part II, Part III and Part VI shown on drawings marked:

Westmeath County Council Compulsory Purchase (No.4) Order, 2010, N52 CPO-01, N52 CPO-02, N52 CPO-03, N52 CPO-04, N52 CPO-05 and N52 CPO-06 and sealed with the seal of the Local Authority and deposited at the offices of the Local Authority (hereinafter referred to as “the deposited maps”).

(2) The land described in Part I and Part II of the Schedule hereto and coloured grey on the said map is land other than land consisting of a house or houses unfit for human habitation and not capable of being rendered fit for human habitation at reasonable expense.

(3) Subject to any necessary adaptations, the provisions of:

(a) the Lands Clauses Acts (except sections 127 to 132 of the Lands Clauses Consolidation Act, 1845, and article 20 of the Second Schedule to the Housing of the Working Classes Act, 1890), and

(b) the Acquisition of Land (Assessment of Compensation) Act, 1919, as amended by the Acquisition of Land (Reference Committee) Act, 1925, the Property Values (Arbitrations and Appeals) Act, 1960, and the Local Government (Planning and Development) Act, 1963 (as applied by section 265(3) of the Planning and Development Acts, 2000 to 2009),

as modified by the Third Schedule to the Housing Act, 1966 are hereby incorporated in this order and the provisions of those Acts shall apply accordingly.
